DISTRIBUTOR MEMBER

Any multi-product line company whose principal business is the supply and/or distribution of products to the sign industry. **\$750.00 per year**

PRODUCT MANUFACTURER MEMBER

Any limited-product line company and/or their manufacturer representative whose product line is incorporated into the finished product by the sign industry. **\$250.00 per year**

GRAPHIC/COMMERCIAL SHOP MEMBER

Any company not required by law to maintain a State of Minnesota Contractors License in order to engage in the company's principal business related to the on-premise sign industry. Applicable business and sales tax licenses and Certification of Workers Compensation shall be maintained by the company as required by governing law. **\$200.00 per year**

ASSOCIATE MEMBER

Any company and/or organization that conducts related business with the on-premise sign industry and whose principal business operations involve consulting services, publications, insurance, trade schools, government entities, and/or other professional associations. Individuals, or other entities not listed above, who can demonstrate interest with the sign industry, may become members of the Minnesota Sign Association at the discretion of the Board of Directors. **\$200.00 per year.**

SIGN BROKER MEMBER

Any company and/or organization that conducts related business with the on-premise sign industry and whose principal business operations involve being an intermediary who facilitates the buying, selling, or leasing of signage space or services between sign companies and clients. **\$600.00 per year.**

WHOLESALE SIGN MANUFACTURER MEMBER

Any company and/or organization that conducts related business with the on-premise sign industry and whose principal business operations involve producing signage in large quantities for resale to sign shops, retailers, or other businesses, typically offering a wide range of customizable options and competitive pricing. **\$600.00 per year.**
